## What is this product?

**Type :** Equity Fund. This is an investment fund established as a Company With Variable Capital (SICAV).

**Objectives :** The sub-fund's objective is to provide long-term capital appreciation.

**Investment policies:** This sub-fund invests directly or indirectly at least 80% of the sub-fund's net assets in equity and equity-related securities issued by companies located throughout the world with a focus on the evolution of artificial intelligence, quantum computing, machine learning, robotics and all related technologies. Indirect exposure is obtained by investing in financial derivative instruments on equity and equity-related securities and / or equity indices.

The sub-fund may also invest (on an ancillary basis) in preference shares, debt securities convertible into common shares, warrants and other equity linked instruments issued by any corporations engaged in infrastructure related business.

The sub-fund may also invest:

- up to 20% of its net assets in debt securities and money market instruments issued by governments, supranational institutions or government entities of developed countries and / or corporations having their head office in a developed country.

- up to 5% of its net assets in not rated securities

- up to 10% of its net assets in cash

- up to 10% of its net assets in units of UCITS and/or of other UCIs

- up to 20% of its net assets in equities and equity-related securities issued by companies having their head office and / or carrying out the majority of their economic activities in an emerging country.

The sub-fund may invest in financial derivative instruments such for example futures and options for hedging and efficient portfolio management purpose.

The sub-fund will aim at maintaining a leverage lower than 200%, calculated on the total of all derivative instruments' notional amounts.

The sub-fund may also invest in derivatives such as forward currency contracts for hedging purpose.

The sub-fund may invest up to 10% of its net assets into SPACs.

The sub-fund promotes environmental and social characteristics, but does not have as its objective a sustainable investment.

**Benchmark:** The sub-fund is managed actively without reference to any benchmark.

**Redemption and Dealing:** The Net Asset Value (NAV) of the sub-fund is calculated on daily basis. Redemption requests may be made in writing on each NAV valuation before 13:00h CET (dealing cut off time).

For significant redemptions, more than 5% of total assets, a non- standard procedure may be applied.

**Distribution Policy:** This Share Class does not pay dividends. Income generated is reinvested.

**Launch date:** The sub-fund was launched on 15/03/2006.

Sub-fund Currency The reference currency of the sub-fund is EUR.

**Switching between Funds:** Shareholders may switch all or part of their holdings into shares of another sub-fund provided they meet the minimum holding requirements of the destination sub-fund. Switching orders must be provided in writing. Full details of the switching process are given in the prospectus.

**Maturity :** The Fund is established without limits of duration

**Intended retail investor :** This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.



## What are the risks and what could I get in return?

Risk indicator



The synthetic risk indicator assumes that the product is held for 5 years and is an indicative indication of the level of risk of this product compared to other products. It expresses the probability that the product will suffer monetary losses due to movements in the market or due to our inability to pay you what is owed. We have rated this product at level 5 out of 7, which corresponds to a medium high risk class. This rates the potential losses from future performance at a medium-high level and poor market conditions will likely impact our capacity to pay you. This product does not include any protection from future market performance, so you may lose all or part of your investment. The possible payout will depend on future market performance, which is uncertain and cannot be predicted accurately. ## What happens if Symphonia Lux Sicav is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should we default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.



## What are the costs?

The expenses incurred are used to cover the Fund's operating expenses including the costs of marketing and distribution of the Fund. These expenses reduce the potential return on investment. The tables show the amounts taken out of the investment to cover different types of costs. These amounts depend on the size of the investment, the length of time the product is held, and the performance of the product. The amounts are shown here for illustrative purposes and are based on an example investment amount and several possible investment periods. The following was assumed: In the first year recovery of the invested amount (0 % annual return). For the other holding periods, the product was assumed to have the performance indicated in the moderate scenario; EUR 10 000 per year of investment.
