## What is this product?

**Type** : Flexible Fund. This is an investment fund established as a Company With Variable Capital (SICAV).

**Objectives** : The Sub-fund's objective is long-term capital growth through a flexible investment approach. This is a flexible Sub-fund that seeks absolute return targets over a medium to long-term horizon with a high-risk profile.

**Investment strategy**: The management style is flexible, and the investment philosophy focuses on achieving absolute returns in the medium term through the ongoing selection of financial instruments, including both directional assets (equities, bonds) and non-directional investment strategies. Investment choices are based on macroeconomic analysis to forecast trends and developments in interest rates and currencies, as well as on economic and financial analysis for selecting companies with the best growth prospects, with particular attention to industrial strategies, management quality, financial structure, and business model. Technical analysis is used as a complementary tool. UCITS and other UCIs subject to investment are selected and continuously monitored by managers based on (i) quantitative assessment of performance and composition of managed portfolios and (ii) qualitative assessment relating to management styles, investment policy, and research activity supporting investment decisions.

**Investment policy**: In general, the main focus – also considering the name of the Sub-fund – will be on the equity component. However, under specific market conditions, the Delegated Investment Manager may deem appropriate to shift the allocation toward the bond component. The allocation of the Sub-fund's investments across asset classes – particularly between the equity and bond components – may vary significantly over time. The equity component may range between 0% and 100% of the Sub-fund's total assets without any restriction in terms of capitalization; the bond component (including money market instruments) may account for up to 80% of the Sub-fund's total assets. The Sub-fund may invest up to 50% of its net assets in emerging markets. The Sub-fund is not subject to any restrictions in terms of countries, geographical areas, sectors, duration, currencies, However, the minimum credit rating of bonds in which the Sub-fund will invest is BB-, but the Sub-fund will not invest more than 20% of its net assets in non-investment grade bonds having a credit rating from BB- to BB+. The Sub-fund may invest in debt securities which are not rated by credit agencies if they are considered to be equivalent in risk to at least BB- debt securities by the Delegated Investment Manager at the time of investment. The Sub-fund may invest up to 10% of its net assets in structured securities. These components include not only direct investments in securities but also the proportion invested in UCITS and other UCIs consistent with the Sub-fund's investment policy. The Sub-fund may use derivatives for: (i) hedging purposes; (ii) more efficient portfolio management; (iii) investment purposes. Derivative exposure may not exceed 100% of the Sub-fund's net assets (leverage of 2).

**Benchmark**: The sub-fund is managed actively without reference to any benchmark.

**Redemption and Dealing**: The Net Asset Value (NAV) of the sub-fund is calculated on daily basis. Redemption requests may be made in writing on each NAV valuation before 13:00h CET (dealing cut off time).

For significant redemptions, more than 5% of total assets, a non- standard procedure may be applied.

**Distribution Policy**: This Share Class pays dividends. Income generated is distributed on an annual basis.

**Launch date**: The sub-fund was launched on 06/07/1998.

**Sub-fund Currency** The reference currency of the sub-fund is EUR.

**Switching between Funds**: Shareholders may switch all or part of their holdings into shares of another sub-fund provided they meet the minimum holding requirements of the destination sub-fund. Switching orders must be provided in writing. Full details of the switching process are given in the prospectus.

**Maturity** : The Fund is established without limits of duration

**Intended retail investor** : This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.



## What are the risks and what could I get in return?

Risk indicator



The synthetic risk indicator assumes that the product is held for 5 years and is an indicative indication of the level of risk of this product compared to other products. It expresses the probability that the product will suffer monetary losses due to movements in the market or due to our inability to pay you what is due. We ranked this product at level 4 out of 7, which corresponds to a medium risk class. This means that potential losses due to the future performance of the product are ranked in the medium level and that poor market conditions could affect the ability to pay you what is due. This product does not include any protection from future market performance, so you may lose all or part of your investment. If we are unable to pay you what is due, you may lose your entire investment.

The possible payout will depend on future market performance, which is uncertain and cannot be predicted accurately. The unfavorable scenario, moderate scenario, and favorable scenario shown are illustrations based on the worst performance, average performance, and best performance of the product and possibly an eligible benchmark over the past 10 years. In the future, markets could perform very differently. The stress scenario shows what the amount repaid might be under extreme market circumstances. The adverse scenario occurred for an investment between 30/04/19 and 30/04/24. The median scenario occurred for an investment between 30/07/15 and 30/07/20. The favorable scenario occurred for an investment between 30/12/14 and 30/12/19. ## What happens if Symphonia Lux Sicav is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should we default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.



## What are the costs?

The expenses incurred are used to cover the Fund's operating expenses including the costs of marketing and distribution of the Fund. These expenses reduce the potential return on investment. The tables show the amounts taken out of the investment to cover different types of costs. These amounts depend on the size of the investment, the length of time the product is held, and the performance of the product. The amounts are shown here for illustrative purposes and are based on an example investment amount and several possible investment periods. The following was assumed: In the first year recovery of the invested amount (0 % annual return). For the other holding periods, the product was assumed to have the performance indicated in the moderate scenario; EUR 10 000 of investment. In some cases, it is possible that the amounts due may be lower: the investor is advised to contact his or her financial advisor or distributor in order to verify the actual amount.

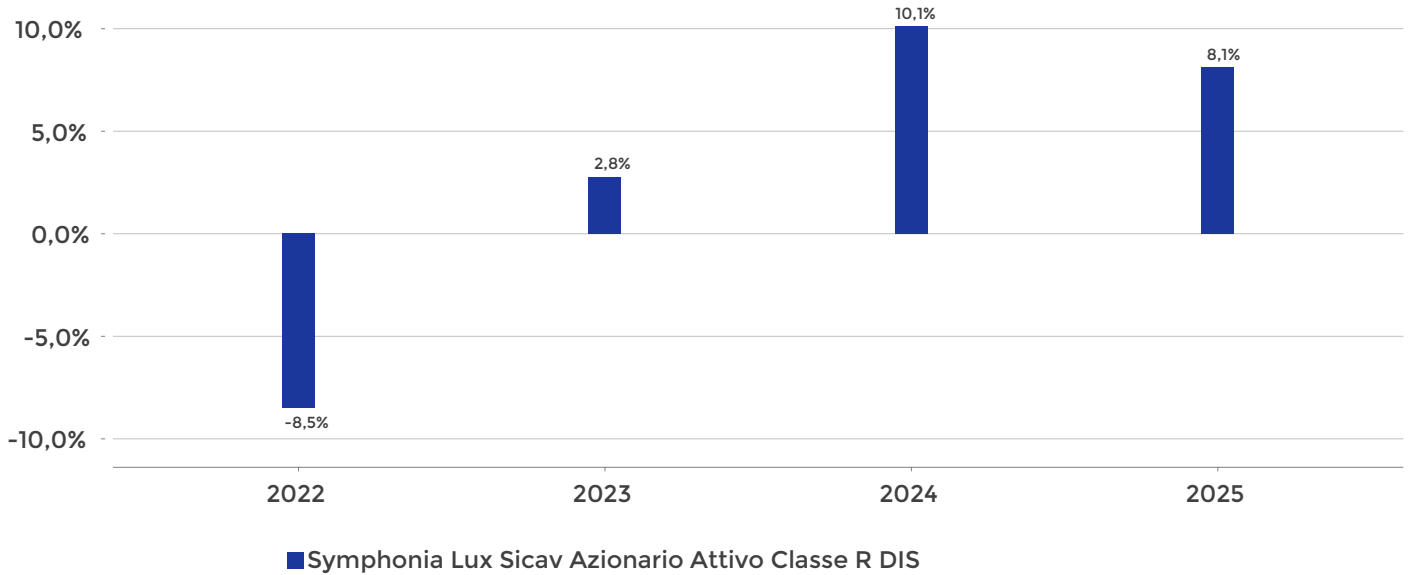
